Paper

We will:

- Minimise the use of paper in the office.
- Reduce packaging as much as possible.
- Seek to buy recycled and recyclable paper products.
- Reuse and recycle all paper where possible.

Recycling

To help us meet our obligations under the Environment Act 2021 to ensure proper separation and collection of recycling, we will:

- Arrange for the collection of dry mixed recycling, food waste and residual (i.e. black bin waste), whether this is through an arrangement we make with a waste collector or by ensuring that any landlord has a waste collection system in place, in compliance with the Government's Simpler Recycling plans and the legal duty imposed on workplaces.
- Separate card and paper from the rest of any other dry mixed recyclables (e.g. glass, metal, and plastic), unless the waste collector collects these together.

Energy and Water

We will seek to:

- Reduce the amount of energy used as much as possible.
